## WHAT IS THIS PRODUCT?

#### Type

The Units are a class of units in Perseo Fund (the "**Sub-Fund**"), a sub-fund of CaixaBank Global Investment Fund (the "**Fund**"). The Fund is formed as a fonds commun de placement. The Fund qualifies as an undertaking for collective investment in transferable securities ("**UCITS**") within the meaning of the Luxembourg law of 17 December 2010 relating to undertakings for collective investment. CaixaBank Asset Management Luxembourg S.A. is acting as management company of the Fund (the "**Management Company**"). The Sub-Fund is a sub-fund of an investment fund, whose performance will depend on the performance of its portfolio as further described in the section "Objectives" of this KID.

#### Term

The Fund, the Sub-Fund and the Units were created for an unlimited duration. The Fund can be dissolved by a decision of the Management Company as further outlined in the prospectus of the Fund. The PRIIP Manufacturer in its capacity as management company can terminate the Fund, Sub-Fund or the Units unilaterally.

## Objectives

The investment objective of the Sub-Fund is to provide unitholders with medium to long-term capital appreciation by investing in a dynamic and diversified portfolio of assets. The Sub-Fund aims to produce returns by investing in various asset classes such as fixed income securities and equities and, in normal market conditions, will have a higher exposure to equities than to fixed income securities. The Sub-Fund invests in the various asset classes either directly or indirectly, by investing in UCITS as described in section 3.4.2 of the prospectus, including eligible Exchange-Traded Funds ("ETFs"), having a similar investment objective, or through the use of derivatives. The Sub-Fund's exposure to equities is minimum 20% of the net assets and can go up to 75% of the net assets. In normal market conditions, the investment manager expects that the Sub-Fund's portfolio will be exposed mainly to equities, but with a moderate as opposed to an aggressive approach to risk. The Sub-Fund will invest into the equities markets worldwide, mostly focused on the United States of America and Europe and, to a lesser extent, investing into the Asian markets mainly through funds that will cover Japan, China, Taiwan, India and South Korea as the main markets. There is no restriction in terms of market capitalisation or sector in relation to the companies the Sub-Fund intends to seek exposure to. The Sub-Fund's exposure to fixed income securities is limited to up to 80% of the net assets. In normal market conditions, the investment manager expects the fixed income exposure of the Sub-Fund's portfolio to be below the equity exposure. In unfavourable market conditions, the investment manager will increase the exposure of the Sub-Fund to fixed income and may do so to the fullest extent permitted by the investment limitation referred to above. The Sub-Fund may invest in or be exposed to fixed income securities of any type (including government bonds and corporate bonds) that will be investment-grade rated for most part. For those fixed income securities whose rating is below BBB- or

equivalent by any major rating agency or deemed by the investment manager to be of equal quality, ie: sub-investment grade securities, investment will be limited to 20% of the Sub-Fund's net assets. In the context of a rating downgrade, a corporate action or other conversions (including corporate restructuring events), this limit may be exceeded on a temporary basis. In this case, the investment manager will seek to reduce its exposure to those instruments as soon as practicable, whilst having regard to the best interest of the investors. The Sub-Fund may be exposed up to 25% in aggregate of its net assets to emerging markets bonds and equities and up to 50% of its net assets to assets denominated in any currency other than the Euro. This Sub-Fund will not invest in distressed securities. The Sub-Fund may use derivatives for the purpose of efficient portfolio management, hedging and to implement investment strategies which aim to achieve the Sub-Fund's investment objective. The Sub-Fund will in principle not make an extensive use of derivatives. The Sub-Fund may invest in derivatives in the form of futures and options traded in official markets including, but not limited to, EUREX, CMT, CBOT and MEFF. The Sub-Fund will not enter into Securities Financing Transactions ("SFTs"). The Sub-Fund will not enter into total return swaps. To achieve its investment goals, for treasury purposes and/or in case of unfavorable market conditions, the Sub-Fund may also invest in money market instruments and transferable securities on an ancillary basis. The Sub-Fund may also hold ancillary liquid assets, such as cash in bank deposits at sight held in current accounts with a bank accessible at any time, for up to 20% of its net assets which may only go beyond the 20% limit in case of exceptionally unfavorable market conditions as further described in the prospectus. The Units are capitalization units which means units that do not pay dividends. The minimum subscription amount for the Units is EUR 100,000. The Units may be subscribed and redeemed upon demand on

each Luxembourg banking day. Taking into account the long-term holding period and the characteristics of the investments, the performance of the Sub-Fund depends on the performance of the investments over time. A positive performance of the investments will lead to the Sub-Fund's positive performance just as a negative performance of the investments will cause a negative performance. The Sub-Fund pursues an activelymanaged investment strategy. The Sub-Fund refers to the following benchmark: 23,28% MSCI Europe TR Net + 24,50% MSCI USA TR Net (USD) + 3,68% MSCI Japan TR Net (JPY) + 9,80% MSCI Emerging Markets TR Net (USD)+ 8,52% ICE BofA 1-3Y All Euro Government + 21,69% ICE BofA 3-5Y All Euro Government + 8,52% ICE BofA 3-5Y Euro Corporate (the "Benchmark"). The Benchmark is indicated for information purposes only, and the investment manager does not intend to track it or to limit the Sub-Fund's portfolio to the constituents of the Benchmark. There are no restrictions on the extent to which the Sub-Fund's portfolio and performance may deviate from the ones of the Benchmark. The investments underlying the Sub-Fund do not take into account the European Union ("EU") criteria for environmentally sustainable economic

activities<sup>1</sup>. The depositary of the Fund is BNP Paribas, Luxembourg Branch. This KID is available in English and Spanish. The latest price for the Units is available at the registered office of the Fund, 60, avenue J.F. Kennedy, L-1855 Luxembourg. The Fund is an umbrella fund offering several sub-funds whose assets and liabilities are legally segregated between each other. Such document only describes the class E of the Perseo Fund. Other classes are also available within this Sub-Fund. Further information on such classes is available in the prospectus of BPI Global Investment Fund. Conversion in and out between sub-funds/classes of units within BPI Global Investment Fund is allowed. Periodic reports and the prospectus, as further outlined in the section "Other relevant information" below, are prepared for the Fund as a whole. #### Intended retail investor

The Units are intended for retail investors who (i) have sufficient past experience and theoretical knowledge of this kind of investment allowing them to assess the risk of investing in this kind of product, (ii) have a long-term investment horizon of 7 years and (iii) have sufficient resources to be able to bear the loss of their entire capital when investing in the Units. The need of the retail investor to be able to bear the loss of their entire investment is due to several risks including market risk, which can significantly impact your return on investment. These risks are further described in the section "What are the risks and what could I get in return?" below. Investors should be willing to assume a risk of 3 out of 7, which is a medium-low risk.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

## Recommended holding period: 7 years

The Sub-Fund is aimed at investors with a high risk tolerance who assume a perspective of capital appreciation in the medium/long term and, as such, are willing to tie up their savings for a recommended holding period of 7 years.

You can redeem your investment at any time during this period, or hold the investment longer. Investors may redeem their units of the Sub-Fund on any business day in Luxembourg. Cashing in before the recommended holding period may increase the risk of lower investment returns.
